# Important Notes and Additional Eligibility Requirements for Scholarships

# 1. For Asian Development Bank-Japan Scholarship Program (ADB-JSP)

## Eligibility for Asian Development Bank-Japan Scholarship Program (ADB-JSP)

Eligibility requirements for ADB include:

•a national of an ADB borrowing member country;

 $\cdot$ at least two (2) years of full time professional working experience (acquired after a university degree) at the time of application.

### **Important Notes**

- The MPP/IP Desk will contact the nominees upon announcement of admitted applicants. Decisions on scholarship awards will be made independently by ADB. Scholarship nominees, who will be chosen from applicants admitted to GraSPP, are required to complete the application procedures instructed by ADB scholarships, respectively. To process the scholarship nomination, the MPP/IP Desk will share the applicants' personal information with ADB regardless of the provision of 10. Miscellaneous (3) on the Application Guidelines 2021.
- ADB scholarship nominees will be required to submit the scholarship application, which includes a letter of endorsement signed by your employer and the financial certificates to the MPP/IP Desk within several days after the scholarship nomination.
- The scholarship results will be announced by GraSPP.

## 2. For Joint Japan / World Bank Graduate School Program (JJ/WBGSP)

## Eligibility for Joint Japan / World Bank Graduate School Program (JJ/WBGSP)

Eligibility requirements for WB include:

• a national of a World Bank member developing country;

not a holder of a dual citizenship of a developed country;

 $\cdot$  at least three (3) years or more of recent paid development-related experience after earning a bachelor's or equivalent degree;

•being employed in a paid and fulltime position at the time of application.

•The eligibility requirements, including the list of eligible countries, may not be available before the MPP/IP application deadline. Please be noted that there is a possibility that you will not be eligible for the scholarship at the time of scholarship nomination due to change of the WB policy. Check the WB website for more detailed eligibility requirements.

- As the WB will conduct another selection of Partner Programs for cohorts 2021-2024, nomination procedures may be affected by the results of the selection and/or the change of Scholarship Application Guidelines at WB. Please be noted that there is a possibility that UTokyo will not be selected as the WB partner university.
- The MPP/IP Desk will contact the prospective nominees upon announcement of admitted applicants.
- WB applicants must select EPFD policy stream.

# 3. For Japanese Government (MEXT) Scholarship (University Recommendation) - International Priority Graduate Program: MEXT (PGP)

## Important Notes

- The name of MEXT (PGP) at GraSPP is Global Public Policy Professional Development Program.
- An applicant who is a national of an ASEAN country is prioritized.
- An international applicant, who passed the document screening of MPP/IP September enrollment, is eligible to apply for MEXT (PGP). The nominees will be selected among the admitted applicants.

- The Scholarship selection will be conducted independently by MEXT. The final scholarship results will be announced by MEXT around the end of June 2021.
- To process the scholarship nomination, the MPP/IP Desk will share the applicants' personal information with the International Student Adviser at GraSPP regardless of the provision of 10. Miscellaneous (3) on the Application Guidelines 2021.

## 4. For JICA SDG's Global Leader Program

### **Important Notes**

- An applicant who is a government official or academician in a developing country is eligible to apply for the scholarship program. Contact the local JICA office directly.

## 5. For CAMPUS Asia Program

### Important Notes

- The CAMPUS Asia Program is a student exchange / double degree program between Peking University, Seoul National University and the University of Tokyo. Japanese nationals and Korean nationals with Japan's special permanent residence visa are highly encouraged to apply for this option.
- Chinese citizens are not eligible to participate in the CAMPUS Asia Program from UTokyo due to the Peking University's policy.
