GraSPP is now inviting applications for Exchange and Double Degree Programs for Academic Year 2013-2014

At the Graduate School of Public Policy we are actively engaged in international exchange. It is in this spirit of cooperation that we implemented reciprocal exchange agreements with the School of International and Public Affairs (Columbia University) and the Lee Kuan Yew School of Public Policy (National University of Singapore) in the autumn of 2006. In 2008 we signed agreements with the School of International and Pacific Studies (University of California, San Diego campus), Sciences Po (Paris), and the Hertie School of Governance (Berlin). We are also pleased to announce that the Graduate School of International Studies (Seoul National University) and the School of International Studies (Peking University) have joined our partnership of CAMPUS Asia Program is an educational collaboration between China, Korean and Japan. Including the CAMPUS Asia Program universities, now we have total of seven of them. Students at both GraSPP and the partner schools can

enjoy the opportunity to enroll in a diverse range of classes together whilst creating new friendships and experiencing each other's culture. Memorandum of double degrees were also concluded with the Lee Kwan Yew School of Public Policy in November 2009 and with the School of International and Public Affairs in October 2010, and also with SciencesPo. in October 2011. They are the first three double degree programs (henceforth DD) introduced at the Uni versity of Tokyo. Under the DD program students can obtain degrees from both the University of Tokyo and the partner university upon satisfying the graduation requirements of both degrees. We will simultaneously be accepting applications for exchange programs for academic year 2012 at all seven schools as well as DD programs at the three schools. <u>Application process</u>: Applications will be screened in a two-stage process which includes document screening and an interview.

Notification of successful applicants from the GraSPP: Mid-December Exchange Period: The period of exchange depends on each school, but students will generally depart for the partner university in August for either half or one year.
