Application and selection procedure

CASE STUDY (INTERNATIONAL FIELD WORKSHOP) in S2, AY2017

This notice provides prospective applicants for Case Study (International Field Workshop) with information on the application and selection procedure. The field workshop is *tentatively* scheduled for a period from August 14 to 24, 2017. Please find attached the course syllabus (Attachment 1), a list of target organizations (Attachment 2) and records of the past IFW (Attachment 3).

In order to help you better understand the objective and procedure, an information session will be held from 18:45 to 20:00 on Thursday, April 20 in Seminar Room 429/433, Faculty of Engineering Building No. 14 on Hongo Campus.

Those who want to register for this course should submit a proposal as instructed below. Only those who have passed selection process based on the proposal, and interview as needed, are allowed to register during the S2 registration period (June 13-19). Students who have participated in the past IFWs could apply again and might be admitted, but will not earn credits. Please check with the graduate school or program you are currently enrolled in whether financial support would be available.

How to apply

- 1. Please choose two out of the target organizations in Attachment 2 and make a proposal on how you will plan to organize a discussion session on a particular subject with professionals at the two organizations you select.
- 2. Your proposal should define what to be discussed and explain the motivation behind. Please include description on your academic interests and strengths and also implications of the visit for your future career goal—connecting yourself with professionals you will meet could help develop your future career.
- 3. The length of the proposal itself should be **no more than 800 words (12-point font size in A4 paper) in two pages or less** (exception to this limit is explained in Attachment 2). Please make sure to follow this limit—otherwise, the proposal will not be accepted.
- 4. Please submit your proposal **together with your CV** by e-mail to the following addresses with the subject line starting with IFW2017S2 and your family name (for example, Subject: IFW2017S2Nishizawa).

- 5. The application deadline is **17:00 on Friday, April 28 (Tokyo time)**.

- how the applicant could make the good use of the visit to help develop her/his future professional career; and
- *most importantly,* how the proposal attracts attention and interest of professionals at the organizations you select.

3. Teaching methods

This course is organized as a series of meetings and discussion sessions with senior officials, management staff and experts in government agencies, international organizations, global business entities, NPOs, and research institutions located in Asia. Students are required to be actively involved from the preparation stage and participate in discussion during the field workshop based on student different backgrounds, life-experiences, specialized knowledge and skills. The working language is English.

Each student is also required to submit a report with no more than 1,200 words (A4 size) by Monday, August 28, 2017.

The report should be well organized and articulated with a focus on *your thoughts on how you could fill the gap between your own specialized knowledge/skills and the social demand, based on discussion during the field workshop.* Also, the report should propose an action plan to achieve your professional goal in line with your expressed thoughts. You should minimize a description of your own research while discussing how an interdisciplinary approach could potentially maximize the value of your own research in addressing challenges in the real world.

The course grade will be based on: Preparation 20% Participation 50% Individual report 30%
