#### 1. Objectives

This course will aim to motivate students to seek ways to collaborate with diverse stakeholders in the international fora by offering opportunities to discuss with senior officials, management staff and experts in government agencies, international

organizations, global business entities, NPOs, and research institutions located in Washington, D.C. and New York. Planning and participating in discussion with such professionals are expected to help students to identify today's public policy challenges from global perspectives and to design solutions in line with the concept of the Global Leader Program for Social Design and Management (GSDM) [http://gsdm.u-tokyo.ac.jp/en/].

- □ Active involvement is required to lead discussion with professionals on public policy issues to be defined during the planning and preparation stages.
- □ Provide networking opportunities with professionals to develop your future career

Proposals should define public policy issues to be discussed from global perspectives in the context of the overarching theme *"Innovative Approaches to Addressing Global Public Policy Challenges"*.
