Withdrawal of tuition fee

Please note that <u>Monday, March 1</u> is the scheduled withdrawal date. Students who have been approved for reduced payment or have had their application for tuition fee exemption declined and have arranged to pay their tuition fees by direct debit, should make sure they have deposited the amount equivalent to their tuition fees into their account by 15:00 on Friday, February 26. Students who have not registered for direct debit should pay their tuition fees in accordance with the invoice that will be sent by the Accounting Group.




