

What happened to EX/DD programs for AY 2022?

EX Programs

- Most programs got back to normal with face-to-face instructions
- Limited sanitary regulations on/off campus
- Increased #s of applicants and 6 students sent from GraSPP

DD Programs

- ✓ Back to normal and inperson style of instruction
- ✓ Limited sanitary regulations on/off campus
- ✓ Decent #s of applicants overall and 3 students sent from GraSPP

Double Degree Programs

- Can obtain degrees from both the UTokyo and partner university upon satisfying the graduation requirements of both degrees.
- A system where a student works for two different university degrees in parallel, completing them in less time (2 to 3 years) than it would take to earn them separately.

Notes for Double Degree Program 1

- Highly recommend to study at GraSPP at least 1 year before departure.
- Recommend to complete all core/compulsory courses to meet your graduation requirements of GraSPP before your departure.
- Recommend to take as many courses taught in English as possible regardless of your current affiliated courses.

Fairly New Double Degree Program with King's College London

KCL is a major research university in the UK, located in a heart of London.

The Department of War Studies (DWS) is one of the only academic departments in the world focused on understanding the complex realm of conflict, security, and international politics through inter-disciplinary teaching, research and engagement

Key Features:

This is a one-way program starting at GraSPP (1st year) and finish up at KCL (2nd year).

There are 14 Programmes (e.g. MA Conflict, Security & Development, MA International Relations, MA Science & International Security, etc) to choose from.

Completion of all the course work and dissertation at KCL is required.

*No credit transferring from GraSPP to KCL; credits earned at KCL can be brought back to GraSPP.

Completion of the core courses and case studies according to the requirements of your programs at GraSPP before departure is required.

Notes for Double Degree Program 2

- ANU, LSE, and Hertie School <u>require</u> prospective DD students to attend their program with completed MPP/IP core courses.
 - ⇒Be prepared to change your affiliated course to IP after completion of GraSPP nomination by the time of departure.





Hertie School

- ✓ TOEFL iBT 90 or IELTS 6.5 (≥6.0 in each section)
- ✓ To arrive on campus by 19 July 2022
- ♦ Tuition & Fees only payable to UTokyo!!

- ✓ TOEFL iBT 107 (≥21 in WR and ≥20 in other areas) or IELTS 7.0 (≥6.0 in each section)
- ✓ All required core courses and at least 24 credits, including 4 Case Studies credits, completed by end of 1st year

- ✓ MPP/IP student preferred
- ✓ At least TOEFL iBT 100
- ✓ 1st year core courses required by GraSPP completed
- ✓ Master Thesis (~12,000 words) is required

- New system in Sciences Po-GraSPP DD has started in 2016.
 - Joint Admission: up to 10 candidates <u>from the world selected jointly</u> <u>by GraSPP and Sciences Po</u>
 - a total of 4 students for 2016-2018 cohort
 - a total of 10 students for 2017-2019 cohort
 - a total of 7 students for 2018-2020 cohort
 - a total of 6 students for 2019-2021 cohort
 - a total of 4 students for 2020-2022 cohort
 - a total of 7 students for 2021-2023 cohort
 - Start at Sciences Po in the 1st year, finish the 2nd year at UTokyo (for April enrollees: UTokyo-Sciences Po-UTokyo).

UTokyo/ANU: Why Crawford School of Public Policy?

- Enables you to gain perspective on public policy in the Asia-Pacific region, especially from Australia's POV
- Strong focus on policy analysis, research, and other essential coursework
- Chance to network with some of the brightest and best in Australia – outgoing and friendly student body

UTokyo/ANU: COVID-19 Situation

- Australian cases have significantly declined since their peak in January 2022 and remain low
- Strong and flexible response to COVID-19 great deal of planning and preparation goes into online courses, which are offered alongside offline counterparts
- Masks remain mandatory indoors on campus, although it seems this policy may change soon
- Off-campus protocol is laxer; masks are still recommended but generally not required anywhere

UTokyo/ANU: Personal Advice

- ANU offers several short, intensive courses that meet only a handful of times each semester. These are a great way to do a deep-dive into a topic in a time-efficient manner, and you will walk away having learned a lot!
- Some classes offer extra workshops to help with essays, policy memos, and other assignments.
 The people running these workshops are incredibly helpful and offer great insights that will help you improve your writing.

Year 2 at LSE

- Study + live in London, international hub city of Europe
- Opportunity to choose from 1,300+ postgraduate
 courses at LSE → Not restricted to MPA courses
- LSE reputation
- Diverse classmates from around the world
- Coursework is demanding! Be prepared for this

Year 2 at LSE - Capstone Project

- ◆ The Capstone groups tackle socially relevant and topical policy issues and the contribution of MPA students is highly valued by the Capstone clients.
- Students are put into groups of 4-6 for a six-month consultancy style project.
- The Capstone is an excellent opportunity to extend the learnings of Year 1 in the Dual Degree in a professional setting






