01 Vision

Concept

The Model WTO is a student-run initiative at the University of St. Gallen with the purpose of hosting a one-week simulation of World Trade Organization negotiations. Every year since 1997, leaders of tomorrow from across the globe are invited to Switzerland to exchange creative ideas and discuss the future of international trade policy in the exceptional context of the World Trade Organization.

Objectives

Our objective is to sensitize our participants to the current issues of international trade as well as to enable them to have a unique insight into the procedure for adopting trade resolutions. In that sense, the Model WTO offers a unique experience for students to get involved in highlevel training and benefit from the expertise of WTO professionals.

Our purpose exceeds the academic realm. We seek and encourage the exchange of knowledge, the meeting of international students from different backgrounds, and the active participation of young people on important issues within society.

Organization


The upcoming conference will be held from March 30th to April 6th, 2023, at the University of St. Gallen and at the WTO headquarters in Geneva.

The event is organized by seven students at the University of St. Gallen who are supported by an advisory board of six experts in international trade to ensure the quality of the simulation. Moreover, the conference will be supervised by a team of 12 students from the University of St. Gallen who will undertake the role of chairs and will actively guide the negotiations.

03 Topic

The WTO and Inclusive Trade

"Trade has contributed to make the pie bigger, but its shares have not been divided equally. Strengthening the multilateral trading system to make it more open, transparent and equitable could contribute to shared prosperity globally" - Isabelle Durant, former Deputy Secretary-General of the UNCTAD (UNCTAD, 2019)

While free trade and globalization have created jobs, lifted incomes and improved working conditions in some contexts, these trade benefits have not been truly inclusive for all societal levels and for all countries (WEF, n.d.). The COVID-19 pandemic, trade wars and armed conflict have accentuated the need to ensure access to trade benefits and the mitigation of trade risks to marginalized groups, which is why the WTO's annual Public Forum 2022 Towards a sustainable and inclusive recovery: ambition to action the WTO called for more sustainable and inclusive trade rules (WTO, 2022).

While efforts have been made on a multilateral level to integrate small economies into the post COVID-19 economy, as underlined by the Chair of the Committee on Trade and Development (CTD) Dedicated Session on Small Economies in 2021, the WTO equally assumes a vital role in determining which civil society actors are included in multilateral policy making.

Against this background, the model WTO 2023 aims to examine which and how certain levels of society effectively gain from increased trade as a result of globalization and trade liberalization. By focusing on the multilateral dimension, concerns of developing and least developing countries will be addressed and the degree of inclusiveness of the multilateral policy-making of the WTO will be negotiated. Inclusive trade in terms of societal groups, such as gender, indigenous people and MSMEs, will constitute another dimension of the negotiations.



04 Role of Participants

Delegates


The role of the 72 conference participants is to represent one of 12 countries and the country's interests in one of the 6 committees as a delegate. Each committee is composed of one delegate of each of the countries (12 delegates for 12 countries per committee). The delegate's main contribution is made during the negotiations of committee resolutions during which the delegates are to defend the views and interests of the country they represent.

Head Delegates

Each of the 12 countries/delegations is led by one head delegate. Head delegates are responsible for aligning the position of the country/delegation for the conference's debates and negotiations.

Chairs

The role of the chairpersons (12 students at the University of St. Gallen only) is to lead one of the six committees and the negotiation.



- 12 countries with 6 delegates each.
- 6 committees with 12 delegates, each from a different country.
- Every country has one head delegate.
- Each committee has two chairs, some head delegates (not necessarily equally distributed among the 6 committees) and delegates.



05 Application Process

In the **first round**, applicants will need to submit their **CV** along with a **short motivation letter**.

In the motivation letter, the following three questions have to be answered:

- 1) Why do you want to participate in the Model WTO 2023?
- 2) What makes you a good candidate for the negotiations?
- 3) How do you think participation in the Model WTO 2023 will help you in your studies or career?



06 Financial Aid

Application Process

Students can apply for financial aid **if needed**. The financial aid **only includes the payment of** Financial aid will be granted only to students that specifically apply for it.


In order to apply for financial aid, you must: describe your personal situation in an essay. You still have to hand in your motivation letter and regular essay.

the participation fee. The flight and other expenses are borne by the participants. Please take this into account when planning your participation.

We will offer financial aid to **four selected** students. In our decision, we will look at your personal situation, motivation letter and essay.

Applicants that apply for financial aid will be in a **different pot** from those applying regularly. If you apply for financial aid, you cannot apply for the Model WTO regularly, which means you cannot participate if you're not selected to receive the financial aid.



07 Next Steps After Acceptance

After the acceptance of the invitation letter

After the acceptance of the Conference Invitation the **72 selected participants** will be asked to provide us with their country/committee preferences, and they will be allocated accordingly. Following the final phase, participants must submit the payment for the **participation fee of CHF 450 within two weeks**.


The participation fee includes accommodation and meals (breakfast, lunch and dinner) during the week as well as the activities planned for the conference. Expenses such as plane tickets and personal expenses are to be paid by the participant.

Before the conference, a webinar will be held for all the participants to provide them with the necessary information.
