Job Descriptions	Considering its limited duration, this internship will consist of a well-defined deep-dive research assignment, covering two topics related to sustainability reporting and disclosure in Asia, with a focus on climate change.  Depending on whether 1 or 2 interns are recruited, the confirmed duration and the number of hours of internship per week, the above 2 topics may be arranged in different ways, to be discussed at a later date. All candidates must feel comfortable with both topics.  Depending on company needs and intern profile, recruited intern(s) may be involved in other tasks including online communication, additional research/intelligence, however the research described below will constitute the core of the internship.
	Topic 1: Assessment of climate-related financial disclosure quality in Japan and Singapore Japan boasts the higher number of companies having declared support to TCFD recommendations, and TCFD is gaining popularity in other countries in the region, such as Singapore. However, in its 2023 report, the TCFD initiative showed that globally, only 4% of companies disclosing under TCFD follow all the 11 TCFD recommendations. Your research will consist in assessing the level of alignment of climate-related financial disclosure by companies in Japan and Singapore, declared as TCFD supporters, and the recommendations of the TCFD. You will identify gaps between recommendations and actual practices, and produce a report that Asuene may publish as a white-paper or use for other outreach activities. The conclusions of your study will help Asuene better promote its services (Asuene carbon accounting platform, AsueneESG supply chain assessment platform) as a way for companies in the region to better align with TCFD recommendations, to be integrated within ISSB disclosure from 2024. Other ASEAN countries may be included in your research depending on our updated priorities and your capacity.  Topic 2: Review of sustainability reporting regulations in APAC countries  Asuene conducted a basic review of the reporting regulations and practices in a selection of APAC countries in 2022. This review needs to be reviewed and expanded to more countries.  You research will consist in researching the current status of regulations (or official recommendations) regarding sustainability
	reporting/disclosure, with a focus on GHG emissions / climate change. You will also identify plans announced by governments for future new regulations to be implemented up to 2030. Additionally,

	you will suggest recommended actions for companies (Listed/Unlisted/Enterprise/SMEs) in each country, regarding their alignment/preparation for new regulations. You will produce a series of slides summarizing the situation for each country, supported by explanatory notes. You will also pick up some key regulations (eg. "Capital Market Masterplan" in Malaysia) and further introduce them in 1-2 additional explanatory slides. Countries to be covered in this research are: - Priority 1: Singapore, Thailand, Malaysia, Indonesia - Priority 2: Hong Kong, Taiwan, Australia, New Zealand, Vietnam, South Korea

Comments from the institution	This internship will take place within the Global Sustainability Intelligence and Consulting team in our head office in Toranomon, Tokyo, under the supervision of Stéfan Le Dû, General Manager. You will work with other members of the team, as well as with the Japan Consulting Team (who is offering TCFD consulting support to clients in Japan) and the APAC Team (based in Singapore, who is
	dealing with ASEAN clients).  Telework may be allowed for around 1 day per week.
