Overview

Alternative Dispute Resolution mechanism is here to supplement and, in a few cases, to supplant traditional decision-making processes in the public domain. International training workshop on "Dispute resolution in major industrial projects involving state parties" aims at examining and understanding the significance of alternative dispute resolution for policy decision makers who are involved on behalf of states and/or state entities in major industrial projects, with Harvard Business School case study ("The Kashagan Production Sharing Agreement") to be set as a practical illustration. The Workshop is organized by the Asian Development Bank Institute (Japan) in association with CNRS (France), University of Oxford (UK) and SASTRA Deemed University (India).

The international workshop will feature interactive sessions led by esteemed members of academia, experts, and practitioners. The workshop is designed to be particularly beneficial for government officials (such as Ministries of Economics, Industry, and Environment), responsible for policies and projects that engage foreign investors, state-owned entities, as well as researchers and practitioners in this area from ADB's developing member countries. One of its goals is to provide a platform for stakeholders such as public organizations working at the international and national levels, practitioners and researchers to deliberate and discuss on what is required to build new approaches in the field of alternative dispute resolution.

The international workshop will use an interdisciplinary approach that draws on scholars and practitioners from various fields of expertise such as law, public policy, political science, finance and economics. It will be conducted for two days, and the case study and reading materials will be made available to selected participants prior to the event.
