AY2025 Application Guidelines



Objectives and Conditions of the exchange

- 1) This Double Degree program is for full-time students enrolled in the Graduate School of Public Policy; however, students who will be enrolling in GraSPP in the coming academic year may also apply. Furthermore, this program is strictly for those who already have a fundamental grasp of academic concepts and theories pertaining to their studies, also have high proficiency in English as well as who to use those skills to study and obtain a degree in a different academic environment to that of the University of Tokyo. It is therefore NOT to be viewed as just an opportunity to improve one's English. Students should bear this in mind when considering to apply. The main prerequisites for application are a score of iBT 100 or higher on TOEFL examination or IELTS 7.0 and a fundamental understanding of both micro and macroeconomic, and/or basic economics and mathematics as evidenced by the successful completion of the relevant courses in either the student's undergraduate or graduate degrees. Note that the latter prerequisite is also a requirement for graduating from GraSPP (MPP/IP).
- 2) Even upon meeting all of the above requirements, if the destination university decides that the applicant must take supplemental classes to meet their minimum requirements, she/he will be obliged to enroll in all such classes at his/her expenses.
- 3) There will be screening from the destination universities committee, therefore it does not mean all GraSPP nomination will be accepted by the destination universities.
- 4) After being selected and nominated to the destination university by GraSPP, it is basically the sole responsibility for each of the applicant to manage the destination university's application, entry procedures, visa applications, accommodation, application for credit transfers, and all other procedures and preparations relating to the double degree programs.

Academic Prerequisites

By the time of dispatching, it is preferable that students have taken the following courses: Micro for Public Policy or Microeconomics, and Macro for Public Policy or Macroeconomics, and Statistics even if it is not necessarily required by the destination University.

Status at Destination University and Tuition Fees

- This Double Degree programs allow students to study abroad at one of the seven partner universities. Their status at the destination university will be a "full-time degree student," whilst they will be on 'study abroad' at the University of Tokyo.
- Students will receive two university degrees if they can fulfill all the requirements of both universities.

• Tuition fees during the period of study abroad is payable to the destination university and is exempted at the University of Tokyo in the school term of Autumn 2025 and Spring 2026.

ANU does not apply; tuition fees is payable only to the University of Tokyo for the period of study abroad

Credit Transfers

Students can apply for credit transfer into the equivalent credits at GraSPP for courses taken at their destination university. However, GraSPP reserves the right to assess and approve for the credit transfers depending on the course content, duration and modular credits etc, and not all credits would be approved for credit transfers. Therefore, students are encouraged to build their own study plan carefully, and as soon as you have decided on the courses to take, check with GraSPP to make sure that those courses meet your graduation requirements through the prior credit accreditation system. Upon confirmation of acceptance from the destination university, students are to make their study plans and discuss it with their respective Academic Advisor.

*Students can gain certification of no more than 23 credit points.

How to Apply

<1st step for all applicants>

Submit the following documents to GraSPP:

- Double Degree program application form
- Statement of Purpose (500 up to 1000 words)
- TOEFL/IELTS score certificate (photo copy or screen shot is acceptable) *The test has to be taken within the past two years
- Academic transcripts (an original copy) of either undergraduate school and/or graduate school

- Personal Statement of Purpose specifically for the destination university XYuu will be required to submit the above documents and other required documents, if any, either directly online or through GraSPP Exchange Program Coordinator in late January to early February 2025.

- Must have equivalent or higher score of iBT 100 or IELTS 7.0
- Must have completed both of the introductory micro and macroeconomics courses
- Professional experiences are valued

[Other Things to Know]

- Students can apply for on-campus apartment on line through University Apartment Housing (UAH). Also, the Columbia Off-Campus Housing Assistance Office (OCHA) is an important resource for finding non-university housing near campus or in other parts of the city

- Completion of 30 credits out of 54 in residence at SIPA required

 \cdot is a Grandes Écoles, a unique French system of higher education specifically created by the government in order to educate the countries brightest students.

• The School of Public Affairs (SPA) now offers a dual Master's degree program in Public Policy. This 2-year program combines the study of economics, public administration, global health, social change, energy and sustainability—all of which increasingly embraces a plurality of values, ethics and cultural contexts. It is designed for young professionals who navigate the borders of the public and private sectors, and between the regional, national and international levels.

• In September 2016, a cohort system was introduced; all the successful applicants selected jointly by Sciences Po. and GraSPP start their 1^{st} year at Sciences Po and spend their 2^{nd} year at GraSPP.

[Application Requirements]

- Must be (A) a full-time student expecting to be enrolled in the GraSPP courses other than MPP/IP in April 2025 or (B) a prospective candidate of MPP/IP for September 2025 enrollment with an intention to earn Double Degree only with Sciences Po ⇒ follow online application process of Sciences Po (You can apply to MPP/IP separately to seek for other options)
- Must have equivalent or higher scores in the following tests: TOEFL iBT 100 or IELTS 7.0 (no subscore under 6.5)

- 12 January 2025: Online application due at Sciences Po website
- Joint selection process: February through March
- Final announcement of successful applicants: in March
- Sciences Po admission procedure: in June
- Application for visa, accommodation, etc: May to August
- Departure: Late August
- Orientation: Late August early September

XStudent visa application: First, you need to create an account at Campus France (www.japon.campusfrance.org). Once you have created an account there, let the exchange coordinator know your account number. We will then contact Campus France for a group application to process your pre-visa application.

[Other Things to Know]

- As there is no dormitory at Sciences Po, students have to look for housing on their own. Please begin searching from the site below way in advance.

For student visa application, you need to have a proof of housing; therefore, we strongly recommend to have a housing determined by late May.

- Must have equivalent or higher score of iBT 100
- Students who belongs to MPP/IP course preferred
- Must have completed all the core courses required by MPP/IP by the end of his/her $1^{\rm st}$ year

- Having completed the introductory microeconomics, macroeconomics and statistics courses are <u>desirable</u>
- Professional experiences are valued

- mid April: Admission document due (via direct post)
- March to July: Applications for visa, housing, etc

[Other Things to Know]

- Entrance into student accommodation is decided by a lottery. Share house student accommodation is also available close to campus. Dormitory prices are usually between $60,000 \sim 70,000$ yen. Both of the above mentioned types of accommodation are in high demand and are usually difficult to gain entrance into.
- Credit transfer rate: LKY 4 credits = GraSPP 3 credits
- Completion of 44 credits including the 'Policy Analysis Exercise (4 credits)' and 'LKY School Course' out of 64 in residence at LKY required for MPP Degree
- A candidate must have obtained a <u>minimum GPA of 3.00</u> (average of B-) at the end of the course of study before he/she can be considered for award of the degree of Master in Public Policy

- Must have completed all core courses required by MPP/IP including at least 4 case study credits and earned at least 24 credits by the end of his/her 1st year


[Other Things to Know]

- The LSE residential services office allocates over 4000 places across 17 locations in the centre of London. As for the residence halls, a range of contract lengths from 30 weeks to 50 weeks in LSE halls are provided to suit the varying needs of students. [Application Requirements]

- Must be a full-time MPP/IP student enrolled at GraSPP
- Must have Equivalent or higher score of 6.5 on IELTS (at least 6.0 in each section) or iBT 90 on TOEFL (minimum of 20 in Reading and Writing and 18 in Speaking and Listening)
- Must take 5112250 Introduction to Social Sciences during their 1st year at GraSPP (as POGO8096 Policy Research is a pre-requisite course for the compulsory course POGO8035 Research Project).
- Must have completed Spring Semester courses by mid-July to begin their studies at ANU in time; otherwise they may miss the beginning of Semester 2.

[Other Things to Know]

- Students have a number of accommodation options, including graduate residences on campus, off-campus ANU rental properties and private rental properties. The University's on-campus residences and rental properties are in high demand, and accommodation cannot be guaranteed. Students are therefore advised to investigate private accommodation as well. Weekly accommodation prices are approximately:

On campus self-catered \$180-\$230, On campus catered \$330 - \$345, Off campus \$150 - \$350

- Credit transfer rate: Crawford School 6 credits = GraSPP 3 credits
- Completion of 48 Units in residence required for MPP Degree
- Under the MOU with ANU, the U-Tokyo students will pay the tuition only to U-Tokyo.

[Application Requirements]

- Students who belong to MPP/IP in PMIR and International Public Policy course <u>preferred</u>

- Must have equivalent or higher scores on the following tests: IELTS 7.0 (at least 6.5 in each section), TOEFL iBT 100 (minimum of 25 in WR and 23 in each of the other skills). - Must have completed all core courses and case studies according to the requirements of one's program by the end of his/her 1^{st} year.

- January to February: Online application due

- March: Final announcement of successful applicants
- by May: Admission documents submission and Offer letter from KCL
- March to August: Application for visa, housing, etc
- by mid-September: Departure (TBC)
- mid-September: Orientation (TBC)

[Other Important Things to Know]

- This is a <u>one-way program</u> starting at GraSPP (1^{st} year) and finish up at KCL (2^{nd} year).

- No credint transfer from GraSPP to KCL; candidates will do all the coursework <u>and</u> dissertation at KCL. *Candidates can transfer credits earned at KCL to GraSPP as free elective courses.

- Students can apply for King's Residences online and are guaranteed a place in accommodation if they meet the criteria outlined in our Accommodation Policy.
